

## ASSUMED BUSINESS NAME Supplementary Filing Instructions

### Necessity of Certificate

The appropriate Supplementary Assumed Business Name forms must be filed under the following circumstances:

1. An owner changes their name or their residential address.
2. The legal street address of any place of business is changed (business address cannot be a P.O. Box.).
3. A person's name is added to the business organization.
4. An additional business address is established.
5. A person withdraws their name from the business organization.

### Filing Procedures for Supplementary Filings

1. Complete in duplicate the applicable Supplementary Assumed Business Name form. Please type or print in black ink.
2. All owners must sign the form in the presence of a Notary Public and have both copies notarized.
3. Return the Supplementary Assumed Business Name form to the Lake County Clerk's office with the required \$5.00 filing fee (or \$1.50 if the filing is for a Withdrawal of Owner[s] or Cancellation). A date-stamped copy of your filing is issued as your receipt.
4. If the filing is for a Supplementary Assumed Business Name form for Addition of Owner[s], Withdrawal of Owner[s] or Cancellation, you must take the filing receipt to a Lake County newspaper for publication as a legal notice once a week for three consecutive weeks (refer to reverse side for a list of publishers). The first publication must appear in the newspaper within fifteen (15) days of the date the form is accepted for filing in our office. The newspaper will type set the legal notice from your date-stamped copy. The law does not require publication for a Supplementary Certificate for Withdrawal if less than 25% of the ownership is withdrawing.
5. Within fifty (50) days of the date you filed the Supplementary Assumed Business Name form for Addition of Owner[s], Withdrawal of Owner[s] or Cancellation (steps 1, 2 and 3 above), you must file the original certificate of publication issued by the newspaper after the third week of publication. We will issue a receipt for the publisher's certificate you file with us.

**Unless proof of publication is filed with the County Clerk, the Supplementary Assumed Business Name form for Withdrawal of Owner[s] or Cancellation is void.**

**NOTE: Duplicate Assumed Business Name Certificates require a fee of \$1.50 each.**
